- Original qualification evidence (as referred to in the CAS) - note this applies only to students starting a new course, not current, continuing students
- Evidence of your SELT (Secure English Language Test) but only if referred to in you CAS

* You may not need to show this evidence if you qualify for differentiation arrangements based on nationality or if you provided this evidence as part of a previous visa application. Please see additional guidance above.

You will also see instructions relating to the process for preparing your documents for your biometric appointment. For applications where documents are processed digitally, we suggest that you should prepare and scan your documents according to these instructions to avoid any additional fees or delays at the Visa Centre.

Former financial sponsorship

If you have received sponsorship in the last 12 months from a government or an international scholarship agency for all of your tuition fees and your living expenses but no longer receive funding from them, you must provide a letter from your former financial sponsor confirming that they give their consent for your immigration application. If you do not provide this letter, your application will be refused.

Immigration Health Surcharge (IHS)






